Summary

Kyle is Professor of Environment and Sustainability and George Willis Pack Professor at the University of Michigan School for Environment and Sustainability (SEAS). Kyle serves as a faculty member in the SEAS environmental justice specialization. Previously, he was Professor of Philosophy and Community Sustainability and Ottilie Schroeter Timnick Chair in the departments of Philosophy and Community Sustainability at Michigan State University. His research addresses environmental justice, focusing on moral and political issues concerning climate policy and Indigenous peoples, the ethics of cooperative relationships between Indigenous peoples and science organizations, and problems of Indigenous justice in public and academic discussions of food sovereignty, environmental justice, and the anthropocene. He is an enrolled member of the Citizen Potawatomi Nation.

The National Science Foundation has been a major supporter of Kyle's research for nearly a decade. Supporters also include the Bureau of Indian Affairs, U.S. Fish and Wildlife Service, U.S. Geological Survey, National Oceanic and Atmospheric Administration, Mellon Foundation, Swedish Research Council for Sustainable Development, Sustainable Michigan Endowed Program, Spencer Foundation, Marsden Fund, and Health Research Council of New Zealand.

Kyle is involved in a number of projects and organizations that advance Indigenous education and research methodologies, including the Climate and Traditional Knowledges Workgroup, the Sustainable Development Institute of the College of Menominee Nation, the Affiliated Tribes of Northwest Indians, and Ngā Pae o te Māramatanga New Zealand's Māori Centre of Research Excellence. He has served as a facilitator and mediator for Indigenous peoples and communities of color in their efforts to protect themselves from environmental risks. He is a certificate holder of the Training Programme to Enhance the Conflict Prevention and Peacemaking Capacities of Indigenous Peoples' Representatives, from the United Nations Institute of Training and Research.

He has served as an author for the U.S. Global Change Research Program, including authorship on the 4th National Climate Assessment. He is a former member of the U.S. Federal Advisory Committee on Climate Change and Natural Resource Science and the Michigan Environmental Justice Work Group. Kyle's publications appear in journals such as *Climatic Change*, *Weather*, *Climate & Society*, *WIREs Climate Change*, *Environment & Planning E*, *Daedalus*, *Synthese*, and *Sustainability Science*.

He has received the Community Engagement Scholarship Award and Distinguished Partnership Award for Community Engaged Research from Michigan State University, the Bunyan Bryant Award for Academic Excellence from Detroiters Working for Environmental Justice, and the Forty Under 40 Alumni Award and Don Ihde Distinguished Alumni Award from Stony Brook University.
