### **Key Achievements and Impacts:**

- **Developing a program at the University of Michigan, School for Environment and Sustainability to support US Tribes and Indigenous Peoples organizations globally** advance their landback, conservation, and climate change related initiatives – with the technical support of UM-SEAS Masters students, thereby helping Tribes transform land and conservation policy and practice and students learn how to be strong allies for Indigenous Peoples and agents for social change.
- **Catalyzed the transformation of the international ecosystem of organizations supporting Indigenous Peoples and local community leaders and organizations**, to dramatically increase support for the formal recognition of their lands, governance rights, and their central and essential role in conserving and restoring nature to achieve social justice, development, climate, and biodiversity goals.
  - **Instigated and led the establishment of the [Rights and Resources Initiative](#) (RRI) coalition**, and the Rights and Resources Group (RRG), its secretariat, now the world's leading international network of indigenous, community, and Afro-descendant rights holder organizations and their allies, with over 150 affiliated members with rights to over 60% of all tropical forests. RRI has offices in Washington D.C. and Montreal, has had major legal, policy, and political impacts in over 25 countries, and played a key role in promoting the recognition of over 150 million hectares of indigenous and community lands as well as women's tenure rights since 2005.
  - **Co-created and established the [International Land and Forest Tenure Facility](#) (TF), and instigated the creation of the [Community Land and Conservation Finance Initiative \(CLARIFI\)](#)**. The TF is the first international financial mechanism dedicated to securing Indigenous Peoples' and local community land rights, with multi-million-dollar projects in over 15 countries and securing communities' rights to at least 15 million hectares since 2018. CLARIFI complements the TF by mobilizing and directly channeling funding to local organizations and their financial mechanisms for advocacy, conservation, and organizational strengthening, and encouraging donor commitment to raising over \$10 Billion for this cause by 2025.

- **Instigated, co-founded and co-chaired strategic networks of organizations key to overcoming resistance to establishing the recognition of indigenous and community rights as a global norm:** [MegaFlorestais](#), the international network of forest agency leaders representing over 70% of the world's forests; the [Interlaken Group](#) network of leading private companies, investors and NGOs committed to securing community land rights; and the [Path to Scale](#) network of donors, committed to scaling-up public and private investments to secure community rights to meet the global 2030 climate, conservation, and development goals.
- **Successfully transitioned from leadership positions in the RRI organizations** listed above after stepping down in 2021, by recruiting stronger and more diverse [executive](#) and [Board](#) leadership, and securing increased funding for RRI before departing.
- **Dramatically increased the level of public and private funding for indigenous, community, and women's organizations, and their local and international allies.**
  - Led fundraising and deployment of over \$250 million to the RRI network of organizations.
  - Mobilized public and private donors to make a historic [commitment of \\$1.7 billion](#) for the recognition of indigenous and community land rights and channel that funding through their organizations, at the 2021 climate CoP in Glasgow.
- **Co-created and established the [analytical framework for tracking forest tenure globally](#) that is now the international reference, the basis for global advocacy, and subsequent baseline [analyses of land, water, and carbon rights, and the status of global recognition of women's rights to forest lands.](#)** Played a key role in instigating the body of international research that revealed the positive climate and biodiversity impacts of indigenous and community ownership and management of their lands, and the emerging global norm of respecting community land rights in conservation practice.
- **Played a key role in mobilizing and coordinating the research and convenings that led the government of China to advance forest tenure reforms,** benefitting over 300 million people and improving forest cover on over 100 million hectares, with colleagues from the Chinese Center for Agricultural Policy and in collaboration with the China Council on International Cooperation for Environment and Development (CCICED), Forests and Grassland Task Force (1999 – 2008).
- **Established reputation for developing strong working relationships with leaders from indigenous, corporate, and government sectors across the world, mobilizing these diverse actors to see possibility for transformation, find common cause, and develop visions and strategies for action.** Professionally engaged over a sustained period in China, Nepal, India, Indonesia, Mexico, Guatemala, Honduras, Costa Rica, Colombia, Peru, Brazil, Haiti, Dominican Republic, Jamaica, Liberia, Cameroon, DRC, Congo, Kenya, Madagascar, Ethiopia, Canada, UK, Norway, Sweden, Finland, Germany, France, Switzerland, and USA.
